
The information furnished in respect of the proposal are factual and correct. In the event of any information is found to be false, misleading or suppressed at a later date the approval accorded may be wilder with by the ALCTE in pursuance of Clause 12 of ALCTE Regulations, 1994.

- In the event of non-tompliance by the Society with regard to Act, Gazette Regulations/Guidelines, norms and conditions laid down by AICTE from time to time, the AICTE or a body or a person authorized by it will be free to take measures for withdrawal-of its approval without consideration of any related issues and that all liabilities arising out of such a withdrawal would solely be that of the concerned Society.
- The institute by virtue of the approval given by AICTE shall not automatically become claimant to any financial grant or assistance from the Central or State Government.
- The institute shall observe all instructions guidelines issued by the AICTE and its regional office regarding mode of selection of candidates for admissions prescribing fees and on all matters having relevance to maintaining high quality and standards of teaching learning process in the institution. No capitation shall be charged and to charges other than the fee fixed by the Competent Authority shall be levied on students hereby agree to furnish a certificate to the effect on the last date of admissions during every academic year.
